TERMS AND CONDITIONS

Payment Terms:

Net 30 days (subject to credit approval) The customer agrees that any amount unpaid after thirty days will be subject to interest at the rate of 18% per year (1.5% per month) until such unpaid amount is paid in full. Additionally, the customer will be responsible for the reasonable cost of collection of any such unpaid amounts and attorney's fees.

Pricing:

Prices are subject to change without notice.
Products on back order will be shipped and invoiced at the current price on the date that the shipment occurs.

Freight Terms:

1 skid (36 cases) freight prepaid, requires a 48" dock to a business address.
Lift gate required deliveries will incur an additional \$100.00 fee.
LTL residential deliveries will incur an additional \$100.00 fee.
Any damages and/or short shipments must be signed off on trucking company's Bill of Lading and must be accompanied by photos upon submission.

Minimum Order:

The minimum order requirement is 1 case out of our warehouse.

Deliver Claims:

All delivery claims, including requests for proof of delivery, must be received within 30 days of shipment.

Return Policy:

A 15% restocking fee will be applied to all non-supplier shipping error or defect returns.
Returns after 30 days will not be accepted.
All returns must be preauthorized and need to be accompanied by a return merchandise form. Any unauthorized returns will be refused.
All returned merchandise must be in saleable condition and in the original cartons.
Less than case quantities will not be accepted if other than a manufacturing defect.
All returns are to be shipped prepaid by the customer unless the return is a manufacturing error, shipping error, or defect.
**Manufacturer shipping error within 30 days will receive 100% credit. Credit memos will be issued for all returned merchandise*
